BOBS Bids Received Prior to 3pm on Thursday, February 23, 2023

In order to maintain the integrity of the BOBS bid depository system and the Rules, **the BOBS Bids** received prior to 3pm on Thursday, February 23, 2023 were deemed <u>null and void</u> and <u>were not</u> <u>distributed</u> to the Confirmed General Contractors. They were destroyed/deleted.

This decision was reached after discussion with members of the BOBS Review Committee and with the agreement of the President of BCCA.
