As allowed under Rule 1. F. Pre-Bid Interpretations, we are hereby issuing the following clarification to all plan holders. Unless defined herein the Standard Exclusions will apply; *General Contractors are responsible to include all work that may be excluded from a BidCentral Online Bidding for Subcontractor's (BOBS) Bid as they deem necessary.* This document does not imply a requirement to include work not specified.

BOBS Bids Received Prior to 3pm on Wednesday, January 31, 2024

In order to maintain the integrity of the BOBS bid depository system and the Rules, **the BOBS Bids received prior to 3pm on Wednesday, January 31, 2024 were deemed null and void and were not distributed to the Confirmed General Contractors.** They were destroyed/deleted.

This decision was reached after discussion with members of the BOBS Review Committee and with the agreement of the President of BCCA.

BOBS Registration Fee

BOBS Bidders who have registered **do not** need to pay the BOBS fee again: the registration receipt number remains the same for the purposes of submission.

General Contractors who have registered **do not** need to pay the BOBS fee again.

Bid Bonds

Per the Appendix C BCCA BidCentral Online Bidding for Subcontractors Bid Bond form, bid bonds are compliant when the revised bid closing date is within 30 days of the stated written closing date on the bid bond (see below excerpt).


